

## **Proposition A**

Shall the Board of Directors of the Western Dubuque County Community School District in the Counties of Dubuque, Clayton, Delaware, Jackson and Jones, State of Iowa, be authorized to contract indebtedness and issue General Obligation Bonds in an amount not to exceed \$16,500,000 - funds will be used for technology upgrades District-Wide and to build additions to, remodel, improve, repair, furnish and equip the following buildings and sites: Cascade Jr./Sr High School, Cascade Elementary, Drexler Middle/Intermediate School, Peosta Elementary and Western Dubuque High School.

## **Proposition B**

Shall the Board of Directors of the Western Dubuque County Community School District in the Counties of Dubuque, Clayton, Delaware, Jackson and Jones, State of Iowa, be authorized to levy an annual physical plant and equipment levy upon all all taxable property in said School District, said levy not to exceed \$1.00 per thousand dollars of assessed valuation in any one school year, for a period of ten (10) years, commencing with the levy to be made for collection in the fiscal year which begins July 1, 2012, the money received from the levy shall be expended only for those purposes now or hereafter authorized by Iowa Code Chapter 298.
