**Upon the public measure** "Shall the Board of Directors of the Western Dubuque County Community School District in the Counties of Dubuque, Clayton, Delaware, Jackson and Jones, State of Iowa, be authorized to contract indebtedness and issue General Obligation Bonds in an amount not to exceed \$6,350,000 to provide funds to build and furnish a new elementary school building in Epworth; to build and furnish additions to and to remodel, improve, and repair the Cascade Elementary building; and to replace and improve the roof on the Dyersville Elementary building?"
