We the undersigned members of the Board of Supervisors, acting as a Board of Canvassers for the County of Dubuque pursuant to Section 277.20 and 47.2 Code of Iowa, 2000, do hereby certify that the following is a correct abstract of votes cast at the Regular School Election held on September 11, 2001, for and in the Western Dubuque County Community School District according to the certificate of the respective election officials as returned from the precincts in said school district as enumerated herein on the back.


The following persons were declared elected as Directors of the Western Dubuque County Community School District, for a three year term: Tom Miner.

We therefore declare the public measure "Shall the Board of Directors of the Western Dubuque County Community School District in the Counties of Dubuque, Delaware, Clayton, Jackson and Jones, State of Iowa shall for a period of five (5) years, commencing with the Budget Year ending 2003, levy and impose an Instructional Support Tax in an amount (after taking into consideration Instructional Support State Aid) not exceeding seven percent (7%) of the total regular program district cost for the budget year (including monies received under Section 257.14 as a budget adjustment for the budget year) and annually as determined by the Board, levy an Instructional Support Property Tax upon all the taxable property within the School District commencing with the levy of property taxes for collection in the Fiscal year ending June 30, 2003 (the rate of property tax per \$1,000.00 of assessed valuation to be determined by the Board each fiscal year), and to impose an Instructional Support Income Surtax upon the state individual income tax of each individual income taxpayer resident in the School District on December 31 for each calendar year commencing with the calendar year 2002, and each year thereafter, the percent of income surtax not to exceed three percent (3%) to be determined by the Board for each fiscal year, to be used to support any general fund purpose permitted under Iowa law, which includes providing auxiliary service to the private schools in the District, continuing employment of teachers for all-day kindergarten at Bernard, Cascade, Epworth and Farley, purchasing two school buses each year for use by private and public school students, and reducing student fees as determined by Board of Education." **to be defeated.**




