CITY OF ASBURY

Three members of City Council - four year terms: **Robert Blok** received 463 votes, **Mark Nemmers** received 486 votes, **Ronald Wagner** received 442 votes and were declared elected. Terry Arensdorf received 206 votes, Eric Schneider received 227 votes and Jim Abitz received 124 votes.

693 votes were cast in Asbury. 1,712 eligible 11 absentee

CITY OF BALLTOWN

Mayor - two year term: **Herb Sigwarth** received 28 votes and was declared elected. Clete Steger received one vote.

Five members of the City Council - two year terms: **Leon Cummer** received 20 votes, **Ray Klein** received 19, **Bill Rettenmeier** received 20 and **Jerry Sahn** received 19, and **Jason D. Miller** received 19 and all five were declared elected; Pete Dupont and Harlan Pothoff received six votes each, Louis Sigwarth received 5, Clete Steger received three, Tony Oswald received two and Norman Link, Rusty Bahl, Sandy Bahl and Rick Klinkhammer each received one vote.

29 votes were cast in Balltown. 43 Eligible 2 Absentee

CITY OF BANKSTON

Mayor - two year term: **Rick Stoffel** received 6 votes and was declared elected. Joseph Davidshofer and received one vote.

Five members of the City Council - two year terms: **Joe Gotto** received nine, **Sherry Gotto** received eight votes, **Ann Phillips** and **Joe Davidshofer** each received seven votes and **Jerry Thier** received six and were declared elected. Joyce Davidshofer received four votes, Phil Kruse received two and Dave Davidshofer and Rich Stoffel each received one vote.

9 votes were cast in Bankston. 15 eligible

CITY OF BERNARD

Mayor - two year term: **Robert Kenneally** received 37 votes and was declared elected.. Dominic English received four votes.

Three members of the City Council - four year terms: **Patrick Hengtges** received 42 votes, **Michael Kinsella** received 21 votes and **Richard I. McDonnell** received 43 votes and were declared elected. Jim McDonnell received four votes, Debra Mahoney and Nancy Noonan each received two votes, Mike Mahoney, Jason Kremer and Pat McDonnell each received one vote.

One member of the City Council - two year unexpired term: **David McDonnell** received 43 votes and was declared elected. Scattering received one vote.

46 votes were cast in Bernard. 79 eligible 6 Absentee

CITY OF CASCADE

Mayor - two year term: **Rick Knepper** received 137 votes and was declared elected; Scattering received four votes.

Three members of the City Council - four year terms: **Vivian Clemen** received 112 votes, **Becky R. Dolphin** received 144 votes and **David J. Gudenkauf** received 138 votes and were declared elected. Scattering received nine votes.

One member of the City Council - two year unexpired term: **Brian Schlemme** received 132 votes and was declared elected. Scattering received one vote.

CITY OF CENTRALIA

Mayor - two year term: **Michael Siegert** received 12 votes and was declared elected.

Five members of the City Council - two year terms: **Chris S. Clausen** received 12 votes, **Terry Corbett 11**, **Bud Petsche 12**, **Jean Wuertzer** and **Randy J. Laughlin** each received nine votes and were declared elected. Dick Lenz received two votes.

12 votes were cast in Centralia. 75 eligible

CITY OF DUBUQUE

Mayor - four year term: **Terry Duggan** received eight thousand five hundred ninety-two votes and was declared elected. Ann Michalski received two thousand seven hundred eighty-four votes and Scattering received twenty-eight votes.

One member of the City Council at large - four year term: **Dan Nicholson** received five thousand seven hundred fifty-eight votes and was declared elected. Shirley Lang received five thousand one hundred eighty-two votes. Scattering received thirty-four votes.

One member of the City Council Ward One - four year term: **John Markham** received two thousand three hundred ninety votes and was declared elected. Lou Oswald received six hundred twenty-eight votes and scattering received nine votes.

One member of the City Council Ward Three - four year term: **Joyce Connors** received one thousand three hundred seventy votes and was declared elected. Del Robey received one thousand two hundred twenty votes and scattering received nine votes.

On the Public Measure "Shall the City of Dyersville, Iowa, increase the Hotel and Motel Tax collected under Section 422A.1 of the Code of Iowa from six percent (6%) to seven percent (7%) effective January 1, 2002" there were nine hundred forty-five (945) votes cast as follows: Seven hundred twelve (712) in favor of the public measure and two hundred thirty-three (233) opposed. The public measure was declared **APPROVED**.

CITY OF EPWORTH

Three members of the City Council - four year terms: **LuAnn Spiegel** received 88 votes, **Christopher Williams** received 82 votes and **Bart Johnson** received 35 votes and were declared elected. There was a scattering of 16 votes among 14 people.

109 votes were cast in Epworth. 956 eligible

CITY OF FARLEY

Mayor - four year term: **William Einwalter** received 275 votes and was declared elected. Patrick L. Simon received 104 votes.

Two members of the City Council - four year terms: **Jeffery J. Simon** received 255 votes and **Joyce Jarding** 231 and were declared elected. Ron Bell received 211 votes.

382 votes were cast in Farley. 912 eligible 5 Absentee

CITY OF GRAF

Mayor - two year term: **Randy Halvorson** received 10 votes and was declared elected; Penny R. Dalsing and Theresa Walser each received seven votes, Howard Tyler four votes and Dale Udaly received two votes.

Five members of the City Council - two year terms: **Bob Schilling** received 27 votes, **Byron Homer Schueller** received 23 votes, **Richard Soppe** had 21 votes, **Jean Mayne** had 21 and **Ronald Soppe** received 22 and all five were declared elected. Nassir Sahir received six votes, Tracey Dieters five votes, Theresa Walser and Howard Tyler each received three votes and a scattering of 13 votes among nine people.

31 votes were cast in Graf. 44 eligible.

CITY OF HOLY CROSS

Mayor - four year term: **Brian Maiers** received 54 votes and was declared elected. Paul Ross received three votes, Jim Behnke received two and scattering of seven votes among seven people.

Two members of the City Council - four year terms: **Jim A. Behnke** received 53 votes and **Mark Goedert** received 44 votes and were declared elected. Fifteen people received a total of 24 votes.

68 votes were cast in Holy Cross. 211 eligible

CITY OF LUXEMBURG

Mayor - two year term: **Ronnie Ungs** received 38 votes and was declared elected. Emmet Pins received 26 votes. . Two people received a total of five votes.

Three members of the City Council - Four year terms: **Roger J. Oberbroeckling** received 61 votes, **Richard L. Steffen** received 51 votes and **Ronnie Ungs** received 37 and were declared elected. Helen Langle received 21 votes and three people each received one vote.

71 votes were cast in Luxemburg. 166 eligible

CITY OF NEW VIENNA

Mayor - two year term: **Ronald Boeckenstedt** received 42 votes and was declared elected. Scattering received one vote.

Two members of the City Council - four year terms: **Bernard Kluesner** received 39 votes and **Allan Retting** 44 and were declared elected. Scattering received three votes.

46 votes were cast in New Vienna. 278 Eligible

CITY OF PEOSTA

Mayor - two year term: **James Weydert** received 113 votes and was declared elected.

Five members of the City Council - two year term: **Dick Avenarius** received **95 votes**, **Ray Stephan** received 94 votes, **Eric Seyer** **85** votes, **Tom Straka** received 15 votes, and were declared elected. Gary Burds and Tom Ingles each received fourteen votes. The tie was broke by a drawing with **Tom Ingles** declared elected. Rob Burds received 13 votes, Melissa Nemmers received 10 votes and twenty-five people scattered 43 votes. .

On the public Measure: Shall the City of Peosta, Iowa, pursuant to Chapter 422A of the Code of Iowa, be authorized to impose a hotel and motel tax at the rate of seven percent (7%) to become effective on the 1st day of January, 2002, of which not less than fifty percent (50%) shall be used for recreational purposes? There was 22 votes in favor and 105 votes opposed. The public Measure was declared **DEFEATED**.

130 votes were cast in Peosta. 435 eligible 4 Absentee

CITY OF RICKARDSVILLE

Mayor - two year term: **Kenneth Leibfried** received 53 votes and was declared elected. There was a scattering of two votes.

Two members of the City Council - four year terms: **Steve G. Cleary** received 36 votes and **Melvin Wilgenbusch** received 40 votes and were declared elected. Joyce Wessels received 26 votes and a scattering of one.

One member of the City Council - two year unexpired term: **Emil J. Barth** received 36 votes and was declared elected. There was a scattering of five votes among four people.

61 votes were cast in Rickardsville. 118 eligible 1 Absentee

CITY OF SAGEVILLE

Mayor - two year term: **Ralph Dean** received 24 votes and was declared elected.

Two members of the City Council - four year term: **Milt Eichman** received 23 votes, and **James T. Sweeney** received 20 votes and were declared elected.

26 votes were cast in Sageville. 141 eligible

CITY OF SHERRILL

Mayor -two year term - **David Berninger** received 35 votes and was declared elected. Leo Kress received eight (8) votes and scattering received seven votes..

Three members of the City Council - four year terms: **Robert J. Weidenbacher** received 50 votes, **Rhonda Mueller** 44 votes, and **Jim Decker** 45 and were declared elected. Dan Habel received six , Norm Koch received five votes and scattering of 43 votes among 25 people.

Two members of the City Council - two year terms: **Joe Specht** received 23 votes and **Yvonne Nauman** received eight votes and were declared elected.

Terms of office were changed to four years in a special election held in Sherrill on August 14, 2001.

53 votes were cast in Sherrill. 121 Eligible 2 Absentee

CITY OF WORTHINGTON

Mayor - two year term: **Paul Engler** received 62 votes and was declared elected.

Three members of the City Council - four year terms: **Ron Leuchs** received 46 votes, **Daniel Feldmann** and **Dave White** each received 28 votes and were declared elected. Sue Burger received 27 votes, Eldon Trumm received 22 votes and Clarence Tuel received two votes.

Two members of the City Council - two year unexpired term: **Gary Langel** received 55 votes and **M. Georgene Pettinger** received 30 votes and were declared elected. Rich Polfer received 26 votes, Jane Reiter two votes and Michael Heiderscheit received one.

91 votes were cast in Worthington. 242 Eligible 4 Absentee

CITY OF ZWINGLE

Mayor - two year term: **Irene Dahlanan** received 23 votes and was declared elected. Three people scattered five votes.

Five members of the City Council - two year terms: **James Hoerner** received 24 votes, **Homer S. Dahlman, Jr** and **Kerry Reisen** each received 23 votes, **Eldon Manderscheid** received 19 votes and **Bill Saewert** received 13 votes and all five were declared elected. Joan Kunde received eight votes and 12 people scattered 31 votes.
