CITY OF ASBURY

Mayor - four year term: **Rick Anderson** received 362 and was declared elected, Gary Patters Sr received 324 votes, Robert Blok received eight, Gene Blum four votes, Robert Park, David Grass each received one vote.

Two members of City Council - four year terms: **Craig Miller** received 433 votes, **Eric Schneider** 480 votes and were declared elected. Nine others received a total of 15 votes..

One Member of City Council - two year unexpired term: **Deborah A. Roth** received 551 votes and was declared elected. Jim Adams received three votes and seven others received one vote each.

709 votes were cast in Asbury. 1,963 eligible 7 absentee

CITY OF BALLTOWN

Mayor -two year term - **David Beringer** received 21 votes and was declared elected. Dave Baal received six votes, Leo Kress received three and Scattering received six votes.

Two members of the City Council - four year terms: **Norb Kutsch** received 22 votes and **Sharon Kutsch** received 11 votes and were declared elected. Dan Habel, Joe Specht each received four, Dave Eddy, Joe Gonzales and Yvonne Nauman each received three votes. Scattering received 22 cotes

Mayor - two year term: **Paul Engler** received 71 votes and was declared elected. Eldon Trumm received nine votes, and scattering received eight votes.

Two members of the City Council - four year terms: **Mike Heiderscheid** received 76 votes, **Gary Langel** received 30 votes and were declared elected. Mark A. Gaul received 25 votes, Jean Polfer 15 votes, Clarence Tuel five votes, Eldon Trumm three votes and scattering received 12.

Five members of the City Council - two year terms: **James Hoerner** received 21 votes, **Kerry Reisen** received 23 votes, **Eldon Manderscheid** received 17 votes and **Willis Saewert** received 19 votes and **Paul Taylor** received 18 votes and all five were declared elected. Scott Kunde received six votes, Luke Veach received four votes and scattering received three votes.

24 votes were cast in Zwingle. 61 Eligible

CITY OF NEW VIENNA

Mayor - two year term: **Ronald Boeckenstedt** received 92 votes and was declared elected. Kevin Vorwald received seven votes and scattering received six votes.

Three members of the City Council - four year terms: **Matt Helle** received 94 votes, **Patrick A. Hermsen** 71 and **Fred Westhoff** received 95 votes and were declared elected. Amy Vorwald received 21 votes, and scattering received 19 votes.

On the public Measure A: To authorize a change in the allocation and specific use of the local option sales and service tax revenues in the City of New Vienna, Iowa. The present use of the local option sales and service tax revenues in the City of New Vienna, Iowa is 100% for street improvement. It is proposed that all revenues received by the City of New Vienna, Iowa, from the local option sales and service tax after July 1st, 2004 will be allocated and used for the following specific purposes:

50% for street improvements

50% for Sewer Fund

There was 91 votes in favor and 13 votes opposed. The public Measure was declared **APPROVED**.

109 votes were cast in New Vienna. 279 Eligible

CITY OF PEOSTA

Mayor - two year term: **James Weydert** received 35 votes and was declared elected. Tom Ingles received one vote.

Five members of the City Council - two year term: **Richard Avenarius** received 33 votes, **Ray Stephan** received 29 votes, **Thomas E. Ingles** 34 votes, **Robert J. Hackmann** received 21 votes, **Larry Mescher** received 31 votes and were declared elected. Jason Shade received 16 votes.

On the public Measure B: "Shall the term of office of the City of Peosta, Mayor and City Council members be changed from two (2) year terms to four (4) year terms, which terms for Council members shall be staggered? The staggered terms shall become effective on January 1, 2006."

There was 30 votes in favor and 7 votes opposed. The public Measure was declared **APPROVED**.

42 votes were cast in Peosta. 479 eligible 0 Absentee

CITY OF RICKARDSVILLE

Mayor - two year term: **Kenneth Leibfried** received 22 votes and was declared elected.

Three members of the City Council - four year terms: **Emil Barth** received 20 votes, **Gene Paisley** received 17 votes and **Cyril Elsinger** received 15 votes and were declared elected. Sue Desousa received three votes. Melvin Wilgenbusch, Chuck Schmitt, Andy Hall, James Ross and Marc Hanson each received two votes.
