CITY OF ASBURY

Mayor - four year term: **Jim Adams** received 276 votes and was declared elected, scattering received 14 votes

Two members of City Council - four year terms: **Robert Reisch** received 237 votes, **Troy Lorence** received 174 votes and were declared elected. Bob Blok received 162 votes and scattering received five.

332 votes were cast in Asbury. 3,211 eligible 8 absentee

CITY OF BALLTOWN

Mayor - two year term: **Herb Sigwarth** received 14 votes and was declared elected.

One member of the City Council - two year unexpired term: **Frank Lyons** received 37 votes and was declared elected. Scattering received 22 votes.

Angie Ervin received 11, Donna L. Maas 10 votes, Marty Miller 13 votes and Jodi Kunde 14 votes. Scattering received eight votes.
