CITY OF ASBURY

Three members of City Council - four year terms: **Michael Cyze** received 246 votes, **Curt Kiessling** 149 votes, **John E. Richey** 169 votes and were declared elected. **Bob Reisch** received 141 votes, **Bridget Stipanovich** 104 votes and scattering four votes. .

351 votes were cast in Asbury. 2,923 eligible 11 absentee

CITY OF BALLTOWN

Mayor - two year term: **Herb Sigwarth** received 18 votes and was declared elected.

Five members of the City Council - two year terms: **Leon Cummer** received 14 votes, **Pete Dupont** received 16, **Bill Rettenmeier** received 14 and **Gerald Sahn** received 18, and **Ron Schmitt** received 13 and all five were declared elected; Dennis Hoppenworth received five votes, Harlan Pothoff received four and five others shared a total of 6 votes.

CITY OF CASCADE

Mayor - two year term: **Greg Staner** received 249 votes and was declared elected; Scattering received 33 votes.

CITY OF PEOSTA

Mayor - four year term: **Dick Avenarius** received 121 votes and was declared elected. Jim Weydert received 102 votes, Dennis McDonald 13 votes.

Three members of the City Council - four year term: **Cheri Bierman** received 105 votes, **Ray Stephan** received 151 votes, **Brian Edward Recker** received 159 votes were declared elected. Gerald Hess received 97 votes, Karen T. Lyons 95 votes and scattering received six votes..

One members of the City Council - two year terms: **Tom Ingles** received 192 votes and was declared elected. Scattering received six votes

Mayor -two year term - **David Beringer** received 29 votes and was declared elected. Scattering received six votes.

Three members of the City Council - four year terms: **Brian Hefel** received 15 votes, **Robert Wiedenbach** received 26 votes and **Jerome Kutsch** received 20 votes and were declared elected. Scattering received 31 votes

On Public Measure C - "Summary: To authorize a change in the use of the one percent (1%) local sales and services tax in the City of Sherrill, Iowa effective January 1, 2010.

The use of the one percent (1%) local sales and services tax shall be changed in the City of Sherrill, Iowa effective January 1, 2010.

PROPOSED USES OF THE TAX:

If the change is approved, revenues from the sales and services tax shall be allocated as follows:

Seventy-five percent (75%) for property tax relief.

The specific purposes for which the revenues shall otherwise be expended are:

Twenty percent (20%) for sewer fund and

Five percent (5%) for the Park fund.

CURRENT USES OF THE TAX:

Revenues from the sales and services tax are currently allocated as follows:

Seventy-five percent (75%) for property tax relief.

The specific purpose for which the revenues are otherwise expended is:

Twenty-five (25%) for the park fund.

There were thirty-one votes in favor and two votes opposed. The public measure was declared **APPROVED**

Mayor - two year term: **William Burger** received 85 votes and was declared elected. Scattering received four votes.

Three members of the City Council - four year terms: **Dawn Davis** received 71 votes, **Chris Krapfl** received 67, **Marty Marugg** received 62 and were declared elected. Dan Feldmann received 17 votes, Shelly Rettinger seven votes, Eldon Trumm 13 votes and scattering received 18 votes.

91 votes were cast in Worthington. 258 Eligible 1 absentee

Mayor - two year term: **Russell Ryan** received 20 votes and was declared elected. Scattering received two votes.

Five members of the City Council - two year terms: **James Hoerner** received 23 votes, **Kerry Reisen** received 2 votes, **Eldon Manderscheid** received 21 votes and **John Chesney** received 23 votes and **Joan Kunde** received 24 votes and all five were declared elected. Scattering received three votes.
