MINUTES OF FEBRUARY 24, 2014 DUBUQUE COUNTY BOARD OF SUPERVISORS

Present: Wayne Demmer, Daryl Klein and Eric Manternach Chair Demmer called the meeting to order at 1:00 p.m.

GENERAL ASSISTANCE HEARINGS

Motion by Manternach, seconded by Klein, carried unanimously to enter executive session with General Assistance Director Charlie Brimeyer, General Assistance Caseworker Doug Slaats and County Budget Director Michelle Patzner regarding case Y-1-16.

Upon returning to regular session, motion by Klein, seconded by Manternach, carried unanimously to refer case Y-1-16 back to General Assistance.

WORKSESSION - WITH STAFF FROM COUNTY AUDITOR'S OFFICE

The Board requested Network Administrator Alan Grant to give an update on the status of the new phone system.

Motion by Klein, seconded by Manternach, carried unanimously to send a letter to the Auditor relaying our disappointment for not having someone present for this worksession to give a status report on the phone system, not receiving an update on the phone system as requested two weeks ago, and to request a detailed time line report to the Board by March 5th regarding the installation of the phone system.

Motion by Klein, seconded by Manternach, carried unanimously to recess at 2:05 p.m.

Upon reconvening at 2:12 p.m., motion by Manternach, seconded by Klein, carried unanimously to approve services for cases #160035, 166136, 165229, 197007, 164689, 168214, 160675 and 178942.

ADMISSIONS TO COMMUNITY-BASED FACILITIES

Motion by Klein, seconded by Manternach, carried unanimously to approve services for case #9475.

WORKSESSION - WITH CPC

The Board met with CPC Jody Jansen for an update on the MHDS redesign meeting held February 9, 2014 and attended by herself and Supervisor Klein.

FY15 BUDGET DELIBERATIONS

County Budget Director Michelle Patzner told the Board the Notice of Public Hearing for the FY15 budget, the Notice of Public Hearing for the FY14 Amendment #2 and Notice of Public Hearing for the Decrease in Appropriations for FY14 are on the agenda tonight for approval.

Motion by Klein, seconded by Manternach, carried unanimously to approve debt service, as presented, which was submitted by County Auditor Denise Dolan on February 11, 2014.

Ms. Patzner also discussed the grant request from the Farley Area Historical Society and the new request from Project Concern for FY15. The Board did not approve the Farley Area Historical Society request and will decrease Project Concern's request to \$19,005 for direct service in the first amendment for FY15.

EXECUTIVE SESSION - WITH LEGAL COUNSEL

Motion by Manternach, seconded by Klein, carried unanimously to enter executive session with Assistant County Attorney Brigit Barnes, Zoning Administrator Anna O'Shea, County Engineer Bret Wilkinson and County Budget Director Michelle Patzner regarding pending or potential litigation per Iowa Code 21.5(1)©.

WORKSESSION - WITH ZONING ADMINISTRATOR

Upon returning to regular session, the Board met with Zoning Administrator Anna O'Shea regarding zoning complaints. Present were County Engineer Bret Wilkinson, County Budget Director Michelle Patzner, Clarence Kramer, 10833 Utah Street, Dubuque, Candice Beam, 10843 Utah Street, Dubuque and Catherine Mueller, 10854 Utah Street, Dubuque.

Mr. Kramer, Mrs. Beam and Mrs. Mueller all commented on the neighbor at 10777 Key West Drive they believe is running a construction business out of a shed on the property and parking construction equipment on site.

The Board directed Ms. O'Shea to send a letter to the property owner advising him, as a habitual offender, that the County will assess the zoning violation issues, and give him notice

that he has 10 days to clean up the property or a civil infraction will be issued.

WORKSESSION - WITH COUNTY ENGINEER

MEETING WITH SHERIFF AND CONSERVATION DIRECTOR

The Board met with County Engineer Bret Wilkinson, County Sheriff Don Vrotsos, Chief Deputy Greg Egan, Captain Dale Snyder and Conservation Director Brian Preston regarding events being held on county roadways.

The Board directed that a letter be sent to the County Attorney for an opinion regarding the County's liability when law enforcement service is requested by the event coordinator and if the County is able to regulate the event or require a special events permit.

The Board also directed that a worksession be held at the March 10th Board meeting with the County Attorney and the County's liability carrier to discuss the issues.

TELEPHONE CONFERENCE WITH HAROLD CLARK

Mr. Wilkinson and the Board met with Harold Clark, by telephone, to discuss the purchase of right of way from him for the Mud Lake Road project. Mr. Clark was requesting more money than was offered to him for the purchase.

Mr. Clark agreed on the original purchase price and will send the right of way documents back to Mr. Wilkinson.

GENERAL ROAD DEPARTMENT DISCUSSION

Mr. Wilkinson said he received next year's contract from the State for the purchase of road salt. He will contract for 7500 ton for next year's winter road maintenance.

MAILBOX CLAIMS

The Board directed Mr. Wilkinson to authorize Maintenance Superintendent Chad Danielson to pay mailbox damage claims for the ones he deems necessary.
