CITY OF ASBURY

Three members of City Council - four year terms; **Russ Domeyer** received 255 votes, **Craig Miller** received 204 votes, and **John E. Richey** 245 votes and were declared elected. Doran Richard Bush received 125 votes, Curt Kiessling 197 votes, and scattering received 8 votes.

412 votes were cast in Asbury. 3,810 eligible 23 absentee

CITY OF BALLTOWN

Mayor - two year term: **Sherri Sigwarth** received 14 votes and was declared elected. Scattering received 2 votes.

Five members of the City Council - two year terms: **Peter Dupont** received 16 votes, **Hillary Koetz** received 15, **Shelli Schmitt** received 14, **Andy Wilwert** received 14, and **Herbert Sigwarth** received 7 votes and all five were declared elected; Bob Loch received 5 votes and scattering 8 votes.

16 votes were cast in Balltown. 51 Eligible 0 absentee

CITY OF BERNARD

Mayor - two year term: **Rick McDonnell** received 20 votes and was declared elected.

Three members of the City Council - four year terms: **Rory Becker** received 19 votes, **Patrick Hentges** received 16 votes, **Jessica Ries** received 19 votes and were declared elected. Scattering received 2.

19 votes were cast in Bernard. 82 eligible 1 Absentee

CITY OF CASCADE

Mayor - two year term: **Greg Staner** received 187 votes and was declared elected; Marcus Behnken received 162 votes and scattering received 9 votes.

Three members of the City Council - four year terms: **Bill Hosch** received 266 votes, **Michael Delaney** received 295 votes and **Riley Rausch** received 100 votes and were declared elected. Scattering received 67 votes.

On Public Measure B: Shall the Three (3) - Member City of Cascade Municipal Utilities Board, consisting of the municipally-owned electric, gas, sewer and water services be abolished, and established in its place a Five (5) - Member Board of Trustees of the City of Cascade Municipal Utilities Board?

The measure failed with 127 votes Yes and 269 votes **NO**.

401 votes were cast in Cascade. 1,482 eligible 20 Absentee

CITY OF CENTRALIA

Mayor - two year term: **Megan Schmitt** received 20 votes and was declared elected. Scattering received 5 votes.

Five members of the City Council - two year terms: **Chris S. Clausen** received 23 votes, **Judith Murphy** 16 votes, **Verdus Petsche** 19 votes, **MaryAnn Reimer** 18 votes, and **Steve Thul** received 22 votes and were declared elected. Nicole Wuertzer received 15 votes and Scattering received 6 votes.

18 votes were cast in Centralia. 101 eligible 7 absentees

CITY OF DUBUQUE

Mayor - four year term: **Roy D. Buol** received 3,687 votes and was declared elected. Jake Rios received 2,409 votes, John Miller received 23 votes, and scattering received 261 votes.

One member of the City Council at large - four year term: **Ric Jones** received 3,480 votes and was declared elected. Jonathan McCoy received 2,983 votes and scattering 66 votes.

One member of the City Council Ward One - four year term: **Brett Shaw** received 1086 votes and was declared elected. John T. Pregler received 994 votes and scattering received 6 votes.

One member of the City Council Ward Three - four year term: **Kate Larson** received 940 votes and was declared elected. Damian Waid received 687 votes. Scattering received 6 votes.

Two members of the City Council - four year terms: **Michael T. Leuchs** received 35 votes and **Roger Langel** received 37 votes and were declared elected. Scattering received 5 votes.

One member of the City Council - two year unexpired term: **TJ Kloser** received 36 votes and was declared elected. Scattering received 3 votes.

39 votes were cast in New Vienna. 297 eligible 3 Absentee

CITY OF PEOSTA

Mayor - four year term: **Larry Mescher** received 153 votes and was declared elected. Doug Hughes received 142 votes. Scattering received 1 vote.

Three members of the City Council - four year term: **John Kraft** received 164 votes, **Karen Lyons** received 153 votes, and **Kathy Orr** received 172 votes and were declared elected. Jesse Begle received 132 votes, Douglas Weig received 149 votes, and scattering received 20 votes.

298 votes were cast in Peosta. 1,005 eligible 9 Absentee

CITY OF RICKARDSVILLE

Mayor - two year term: **Daniel Doelz** received 23 votes and was declared elected.

Two members of the City Council - four year terms: **Melvin Wilgenbusch** received 22 votes, **Neil Lawver** received 22 votes and were declared elected. Scattering received 2 votes.

19 votes were cast in Rickardsville. 145 eligible 4 absentee

CITY OF SAGEVILLE

Mayor - two year term: **Donald R. Recker** received 18 votes and was declared elected. Wayne Kennicker received 8 votes, and Scattering received 4 votes.

Two members of the City Council - four year term: **Milt Eichman** received 20 votes and **Cheryl Hird** received 22 votes and were declared elected. Jacob W. Kenniker received 8 votes, Samuel L. Kenniker received 7 votes.

22 votes were cast in Sageville. 60 eligible 8 Absentee

CITY OF SHERRILL
