





### Public Measure A

"Shall the Board of Directors of the Dubuque Community School District in the Counties of Dubuque and Jackson, State of Iowa, be authorized for a period of ten (10) years, commencing with the 2019-2020 budget year, (July 1, 2019 to June 30, 2020) to levy and impose an instructional support tax in an amount (after taking into consideration instructional support state aid) not exceeding ten percent (10%) of the total regular program district cost for the budget year (including monies received under Section 257.14 as a budget adjustment for the budget year) and be authorized annually, as determined by the Board, to levy an instructional support property tax upon all the taxable property within the School District commencing with the levy of property taxes for collection in the fiscal year ending June 30, 2020 (the rate of property tax per \$1,000.00 of assessed valuation to be determined by the Board for each fiscal year), to be used to support any general fund purpose allowed by Iowa law including continuation of all day every day kindergarten, continuation of student class size reduction at primary grade levels, continuation of per pupil budgetary allocations for instructional supplies and upgrading of outdated equipment items used for classrooms, curriculum initiatives, science laboratories, industrial technology printing services and other instructional support programs, it being understood that if this proposition should fail to be approved by the voters, such failure shall not be construed to terminate or restrict authority previously granted by the voters to levy a special tax for any one or more of the foregoing purposes."






