Public Measure B


We therefore declare the public measure: "Shall the Board of Directors of the Northeast Iowa Community College in the Counties of Allamakee, Bremer, Buchanan, Chickasaw, Clayton, Delaware, Dubuque, Fayette, Howard, Jackson, Jones, Mitchell and Winneshiek, State of Iowa, be authorized to contract indebtedness and issue General Obligation Bonds to provide funds to remodel, improve, repair, construct, erect, furnish, and equip classrooms, laboratories, and buildings and additions to buildings, including security improvements and upgrades, to make improvements to sites at multiple campus locations and other enrollment locations for use by the Community College, to contract indebtedness therefore, and issue its school bonds in an amount not exceeding \$39,000,000 for those purposes." Is APPROVED.
