AN ORDINANCE PROVIDING FOR OFFICIAL STREET NAMES FOR ALL PUBLIC ROADS IN UNINCORPORATED AREAS OF DUBUQUE COUNTY, IOWA, AND PROVIDING FOR AN ORDERLY STREET AND ADDRESS NUMBERING SYSTEM.

**PART 1
INTRODUCTION**

- 22-1 **PURPOSE.** This Ordinance provides for an orderly street and address numbering system in unincorporated areas of Dubuque County, Iowa, based upon established zero origin base lines and a minimum interval, in feet, to be used hereafter to assign addresses.
- 22-2 **DEFINITIONS.** For use in this Ordinance, the following terms or words shall be interpreted or defined as follows:
 - 22-2.1 **Address Identification Markers** shall mean the method by which the address of each rural business or residence is identified.
 - 22-2.2 **Base Maps** shall mean the maps used by the office coordinating the rural address system in Dubuque County, subject to the provisions of this ordinance.
 - 22-2.3 **Building** shall mean any permanent structure used or intended for supporting or sheltering any commercial or residential use or occupancy.
 - 22-2.4 **E911 Address Coordinator** shall mean the Dubuque County Official designated or appointed by the Board of Supervisors to administer the content of this Ordinance. For the purpose of this Ordinance, the E911 Address Coordinator shall be the County Auditor.
 - 22-2.5 **Engineer** shall mean the Dubuque County Engineer.
 - 22-2.6 **Lot Identification Markers** shall mean the method by which the location of each trailer in a trailer park is identified.
 - 22-2.7 **Person** shall mean any individual, firm, corporation, unincorporated association or other entity.
 - 22-2.8 **Road Name** shall mean the name given a platted and approved road, such name having been approved by the E911 Address Coordinator.
 - 22-2.9 **Rural Address System** means the numbers assigned to each dwelling or business in Dubuque County, Iowa, and the numbers or names of the roads in Dubuque County, Iowa.
 - 22-2.10 **Street Identification Signs** are the means by which the name or number of each rural road or street is displayed.
 - 22-2.11 **Subdivision** shall mean the division of a tract of land into separate lots or parcels for the purpose of transfer of ownership or building development.
- 22-3 through 22-10 Reserved.

**PART 2
GENERAL PROVISIONS**

- 22-11 **EXTENT OF SYSTEM.** The rural address system shall extend over the entire unincorporated area of Dubuque County. Any incorporated area, upon presentation of a resolution from the governing body of such area to the Board of Supervisors and a copy to the E911 Address Coordinator, may also be included in the rural address system.
- 22-12 **BASE LINES.** Address assignments shall be made using zero origins consisting of a north-south base line and an east-west base line. The north-south base line shall extend north and south from the point at which the south boundary of T88NR4E intersects with the west bank of the Mississippi River. The east-west base line shall coincide with and extend east and west from the south boundary of T87NR2E. Street address numbers shall be assigned at intervals of approximately 5.28 feet originating from the east-west baseline for streets running primarily north and south and originating from the north-south base line for streets running primarily east and west.
- 22-13 **METHOD.** For all new roads named after the adoption of this ordinance, addressing will commence from the southern or easternmost point of the road. All addresses will be assigned at the point of intersection of the driveway or entrance with the roadway. All roads will be platted and recorded at the Dubuque County Recorder’s Office and will follow the County Platting Procedures for the establishment of Roads.
- 22-14 **ADDRESS SEQUENCE.** The address sequence will be as follows:
 Odd numbers = North and west sides of road
 Even numbers = South and east sides of road
- 22-15 **SYSTEM.** A listing of all road names, public and private, with associated address ranges will be maintained by the E911 Address Coordinator. The listing will be designated Addendum A to this ordinance and shall be a part of the ordinance.

22-16 through 22-20 Reserved.

**PART 3
ADMINISTRATION**

- 22-21 **IMPLEMENTATION OF SYSTEM.** The E911 Address Coordinator shall:
 - 22-21.1 Verify the accuracy of the base maps that shall be used in the assignment of addresses.
 - 22-21.2 Make all necessary corrections and updates to the maps.
 - 22-21.3 Assign addresses in a manner consistent with Part 2 of this ordinance.
 - 22-21.4 Compile and print a reference map showing all the street names and the scheme

of the address system, to be available at cost, in a size no larger than required to show the above detail and yet suitable for general use.

22-21.5 Coordinate all new address assignments with the U. S. Postal Service and the Dubuque E911 Communications Center.

22-22 **STREET IDENTIFICATION SIGNS.** General erection of street identification signs will not accompany implementation of this rural address system, except that:

22-22.1 The Engineer is responsible for procuring and erecting street identification signs at all intersections of roads, public and private as stated in resolutions of the Dubuque County Board of Supervisors in which dedications of roads are accepted. Street identification signs shall be erected in accordance with the following:

a Placement of all street identification signs shall be subject to the approval of the Engineer who shall inspect the proposed location and determine the best placement before authorizing the installation of a sign.

b The Engineer shall maintain signs on private roadways in accordance with this section. The persons or association owning the road shall pay the actual cost of such maintenance.

c Any person desiring a new or replacement street identification sign shall apply to the Engineer. Upon receipt of the application the Engineer shall determine the fee for the provision of the sign which shall equal the estimated actual cost of the installation, including materials, equipment, and labor. Upon prepayment of the fee the Engineer shall provide and install the sign consistent with Section d.

d All street signs shall meet the following specifications:

(1)Location - Signs are to be located to the right of the intersection near stop sign (if any), or twelve feet (12') from the edge of the pavement, or from the edge of gravel roadway. The bottom of the sign will be seven feet (7') above the shoulder of the road as required by the manual on Uniform Traffic Control Devices. Actual location of each sign depends upon the inspection of the intersection by the Engineer or designee.

(2)Materials - [Amended May 10, 1999]

(a) Public Streets and at intersections with county roads - Aluminum blanks shall be used for sign material eight-inches (8") high by fifty-four inches (54") length maximum size, sign facing to be on both sides of the blanks. Thickness of material shall be eight-hundredths of an inch (0.080") minimum. (The Engineer may approve signs with one side facing.)

(b) Private streets in subdivisions - Aluminum blanks shall be used for sign material six-inches (6") high by forty-eight inches (48") length maximum size, sign facing to be on both sides of the blanks. Thickness of material shall be eight-hundredths of an inch (0.080") minimum. (The Engineer may approve signs with one side facing.)

(3)Sheeting -

(a) Public Streets and at intersections with county roads - Reflective sheeting

- shall be High-Intensity grade green background with white letters. Letters shall be capital cased. Signs shall have facings on both sides, with six-inch (6") letters. (The Engineer may approve signs with one side facing.)
- (b) Private streets in subdivisions - Reflective sheeting shall be High-Intensity grade green background with white letters. Letters shall be capital cased. Signs shall have facings on both sides with four-inch (4") letters. (The Engineer may approve signs with one side facing.) [Amended May 10, 1999]
- (4) Mounting - Post mounting cap shall be diecast aluminum with brackets to fit a two and three-eighths inches (2-3/8") OD post (The Engineer may approve a square post). Post shall be breakaway type tubular post two and three-eighths inch (2-3/8") OD by thirteen feet (13'). All screws, bolts, and fastenings must be zinc coated.
- (5) Installation - Signs will be installed only by Secondary Road personnel.
- e Tampering with, defacing, painting, removing, altering, or intentionally damaging any street sign shall be a county infraction if the value of the damage does not exceed one hundred dollars. The penalty for a first violation shall be one hundred dollars. The penalty for a repeat offense shall be two hundred dollars.
- 22-22.2 Maintenance or replacement of street identification signs installed by direction of a resolution of the Board of Supervisors adopted prior to the effective date of this ordinance shall be done by the Engineer, pursuant to Sections 22-22.1a, 22-22.1b and 22-22.1c.
- 22-23 **ADDRESS IDENTIFICATION MARKERS**
- 22-23.1 An address will be assigned for every house, store, or building situated on premises fronting any roadway as provided in Section 22-2.3. Any address number assigned or used prior to the effective date of this ordinance that is different from the newly assigned address number shall be void from the time the new address number is assigned and shall not be used thereafter.
- 22-23.2 The provisions of this ordinance shall not apply to accessory buildings but may apply to such buildings located on a separate unit of frontage if requested by the owner or proprietor and approved.
- 22-23.3 Address Identification Markers for the Rural Dubuque County will be provided with the assigned address number affixed and shall be placed to the right of the driveway on the right of way line as the property is faced from the road. Alternate placement will be allowed only by written approval from both the Joint E-911 Public Safety Board and the Board of Supervisors. Property owners shall be responsible for the purchase and maintenance of the address identification markers at commercial and residential facilities. The fees for the purchase and installation of said markers shall be included in the building permit fee at the time the permit is issued. Trailer parks will be assigned one (1) address number for the park location, with an Address Identification Marker located at the main entrance.
- 22-23.4 Lot Identification Markers for each unit in the trailer parks shall be assigned and

placed by the lot manager or designated party. The numbering sequence shall be approved by the Fire Chief within the District in which the trailer park is located. The park owner will be responsible for the purchase, installation, and maintenance of the Lot Identification Marker for each lot in the park. The signs shall be placed on each unit, visible from the traveled portion of the roadway system, and conform to the same standards required for the Address Identification Markers within the County of Dubuque, Iowa.

- 22-23.5 All Address Identification Markers and Lot Identification Markers shall meet the following specifications:
- a Material – Aluminum blanks shall be used for sign material six-inches (6”) high by eighteen inches (18”) long. Thickness of material shall be eight-hundredths of an inch (0.080”) minimum.
 - b Sheeting – Reflective sheeting shall be High-Intensity grade blue background with white letters, for Address markers, black background with white letters for Lot identification markers for trailer parks. Address markers shall have facing on both sides, with four-inch (4”) numbers, Lot markers shall have facing on one (1) side, with four-inch (4”) numbers.
 - c Installation – Address Identification Markers will be installed only by Secondary Roads personnel or a party designated by the Engineer. Lot Identification Markers shall be installed by the owner or person designated by the owner of the trailer park.
- 22-23.6 Maintenance or replacement of Address or Lot Identification Markers installed by the direction of the Board of Supervisors in a resolution adopted prior to the effective date of this ordinance is the responsibility of the homeowner, business owner, or the park operator.

22-24 **MAINTENANCE OF STREET ADDRESS SYSTEM.**

- 22-24.1 The Engineer shall be responsible for the maintenance of the street identification markers in Dubuque County, including private roadway systems, under direction of the Board of Supervisors and the Joint E-911 Service Board.
- 22-24.2 The E911 Address Coordinator shall be responsible for the assignment of all new addresses, updating maps, making available new maps, and inspecting the rural areas of Dubuque County to ensure compliance with the provisions of this ordinance.
- 22-24.3 All costs of changing a road name and replacing road signs as a result of such change shall be borne by the petitioners, who shall, at the time the request is submitted, submit an amount deemed by the Engineer to be sufficient to cover said costs. This money shall be refunded if the petition is denied.
- 22-24.4 Process for changing a road name:
- a A petition for change of road name shall be signed by not less than 60% of the owners or contract purchasers of land fronting the road. The petition shall be submitted to the Board of Supervisors.
 - b The Board of Supervisors or their designee will determine that the proposed change does not duplicate in sound or spelling any existing road name in Dubuque County prior to approval of the change.

- c A change of road name is an amendment to this ordinance and shall be adopted pursuant to the procedures set out in Iowa Code Section 331.302.

- 22-25 **ADDRESS ASSIGNMENTS.** Every person making application for a Building Permit for the construction of a building as defined in 22-2.3 of this ordinance shall be given an application form for the assignment of a rural address number. The E911 Address Coordinator upon receipt of this application shall issue an address within fourteen (14) days of receipt of the application. A site plan and access plan shall be required prior to the assignment of any rural address number.

- 22-26 **PENALTY.** Any violation of this ordinance or any interference with the implementation or maintenance of or refusal to use the rural address system shall be a county infraction which is punishable by civil penalty of one hundred for each violation, or if the infraction is a repeat offense a civil penalty of two hundred dollars for each repeat offense.

- 22-27 **CORRECTION OF ADDRESSES ISSUED IN ERROR**
- 22-27.1 The E911 Address Coordinator will notify the owner of the property when it is determined the address currently in use is in error.
- 22-27.2 The E911 Address Coordinator shall re-issue a new address that meets the requirements of the Rural Addressing System.
- 22-27.3 The E911 Address Coordinator shall notify the following entities that there has been a correction to the address:
 - a Dubuque E911 Communications Center
 - b Dubuque County Assessor’s Office
 - c Dubuque County Elections Office
 - d Dubuque County Health & Zoning
 - e U. S. Postal Service
- 22-27.4 The Board of Supervisors shall determine the assessment of costs related to correcting an address.

- 22-28 **SEVERABILITY CLAUSE.** If any section, provision, or part of this ordinance shall be adjudged invalid or unconstitutional, such adjudication shall not affect the validity of the ordinance as a whole or any section, provision or part thereof not adjudged invalid or unconstitutional.

- 22-29 through 22-30 Reserved.

**PART 4
EFFECTIVE DATE**

- 22-31 **EFFECTIVE DATE.** This Ordinance shall be in effect after its final passage, approval, and publication as provided by law.
