Explanation of increases in the budget:

The proposed percentage changes in Requested Tax Dollars-General Services and Requested Tax Dollars-Rural Services are due to growth in taxable valuations for the Budget Year Effective FY 2023/2024 and adjustments made for rising costs. The requested tax dollars support the operations of Dubuque County based on departmental budgets and improvements approved by the Dubuque County Board of Supervisors.

The above tax rates do not include county voted levies, mental health and disabilities services levy, debt service levy and the rates of other local jurisdictions.

Regarding proposed maximum dollars, the Board of Supervisors cannot adopt a higher tax asking for these levies following the public hearing.

Budget year effective property tax rate is the rate that would be assessed for these levies if the dollars requested is not changed in the coming year.
