





Three members of City Council - four year terms: **Richard Craig Miller** received 112 votes, **Curt Kiessling** 113 votes, **John E. Richey** 123 votes and were declared elected.

**On Public Measure A:** Whereas the City of Worthington, Iowa presently has local option sales tax providing for the proceeds to be allocated ten (10) percent for recreation, forty (40) percent for tax relief, and fifty (50) percent for streets. The City Council wishes to change the allocation to provide for ten (10) percent for recreation, twenty (20) percent for tax relief, and seventy (70) percent for streets. If approved the change is to go into effect on January 1, 2014.

There were forty-three votes in favor and five votes opposed. The public measure was declared **APPROVED**



## **For the public measure Z:**

SHALL THE FOLLOWING PUBLIC MEASURE BE ADOPTED?

"Shall the Board of Directors of Northeast Iowa Community College (Merged Area I), in the Iowa Counties of Allamakee, Bremer, Buchanan, Chickasaw, Clayton, Delaware, Dubuque, Fayette, Howard, Jackson, Jones, Mitchell, and Winneshiek, cause to continue to be levied a tax not to exceed twenty and one-fourth cents (\$.20 1/4) per \$1,000.00 of assessed valuation in any one year for an additional period of ten (10) consecutive years beginning with the tax levy to be made for collection in the fiscal year July 1, 2016, to June 30, 2017, said tax to be used for any one or more of the following purposes: for the purchase of grounds, construction of buildings, payment of debts contracted for the construction of buildings, purchase of buildings and equipment for buildings, and the acquisition of libraries, for the purpose of paying cost of utilities, and for the purpose of maintaining, remodeling, improving, or expanding Northeast Iowa Community College or for such other purposes as are now or hereafter authorized by law, as provided by Section 22 of Chapter 260C, Code of Iowa?"




